RE: Loan Agreement with Habitat for Humanity of Brevard County, Inc. ("Habitat")

The Loan Agreement between the Authority and Habitat was entered as of July 31, 2008, for a term ending July 31, 2013, which was extended to July 31, 2018. The Loan Agreement provides that \$525,000.00 shall be available to Habitat through the Trustee, Wells Fargo, in increments of the lesser of \$25,000 or actual cost of land acquisition, and the lesser of \$75,000 or actual construction costs for single family homes. Each draw is due upon transfer of the property or within two years, whichever shall occur first. Since the inception of this Loan in 2008, Habitat has drawn \$254,800, all of which was repaid timely. Under a similar Loan Agreement during 2002-2007, Habitat had draws of \$480,000, all of which were repaid timely. Attached is a listing of the loan activity since 2002. In addition to the Loan Agreement, the Authority awarded a grant to Habitat of \$200,000 to fund the Critial Home Repair Program in February, 2012.

Requested Action: Habitat is requesting a five year extension of the existing Loan Agreement under the same terms.
