#### COMMENTS:

- 1) On February 15, 2012, the Brevard County Housing Finance Authority ("BCHFA") and Habitat for Humanity of Brevard County, Inc. ("Brevard Habitat") entered into a \$200,000 grant agreement in connection with the Critical Home Repair Program.
- 2) Under the terms of the grant agreement, Brevard Habitat is to use the moneys to perform repairs to correct code violations, improve weatherization, increase energy efficiency, overcome accessibility barriers, and/or upgrade the exterior of the residences of eligible persons and families. To be eligible, the person(s) or family(ies) must (1) own and permanently reside in the single family residence located in Brevard County and (2) have a total income that does not exceed 50% of the area gross median income.
- 3) Under the terms of the grant agreement, Habitat is to provide the BCHFA with quarterly or more frequent reports on the use of the grant funds and is to certify compliance with its business plan and the presented (i.e., by Habitat) proposal. The certification is attached.
- 4) Under the terms of the grant agreement, individual residence repairs are limited to \$15,000.
