During the months of January, February and the first half of March, 2019, twenty five (25) first mortgage loans closed, all of which utilized the Authority's second mortgage DPA.

The following is the status of the referenced program as of February 28, 2019:

Pending loans: There are 9 closed loans and 8 loans reserved this month, all of which will utilize the Authority's DPA second mortgage.

The maximum DPA loan amount was reduced to \$7,500 effective for reservations made on or after October 1, 2018. At the same time, the mortgage interest rate was increased from 5.0% to 5.125%. Loan originations declined between September and December, 2018, but have increased during 2019, as indicated in the attached summary of loans for 2018 and 2019. If loans continue to originate at the current rate, the funds on deposit in the DPA custody account will be sufficient to provide DPA loans through May, 2020.

Attached are status reports on the DPA and GNMA Custody accounts as of March 18, 2019, and a summary of GNMA profits as of February 28, 2019.
